## Wilmington University Returning/Repaying your Loans

Wilmington University will assist you in returning a credit balance from your student billing ledger to your lender for either a federal student loan or a private education loan within the <u>current</u> academic year (11-12) by submitting a "Loan Change Request" form to the Financial Aid Office (FAO). Once you have submitted this form, your request will be processed, and you can review your loan return information by accessing your WebCampus account. In addition, you will receive a letter from Wilmington University confirming the return of the federal or private loan funds.

If Wilmington University has already disbursed your term's refund and you wish to return that amount to your lender, kindly follow these simple instructions:

- 1. If your refund was disbursed via a HigherOne check, submit the check to Wilmington University with a **signed** and completed Loan Change Request form to return funds to your lender.
- 2. If you opened a HigherOne account and your refund remains in that account, either communicate the WilmUDebitCard numbers to a Wilmington University staff person or present the card in person. Prior to requesting the payment via your WilmUDebitCard, contact HigherOne (telephone number is on the reverse side of your card), stating you require a one day only increase to your daily limit. This permits Wilmington University to process the payment in one transaction. Your signed statement to return these funds is also required.

If you wish to repay any funds resulting from a <u>prior</u> academic year, please contact your lender.
